The bidders should be registered with Pakistan Engineering Council (P.E.C) for the Year 2018-19 in relevant category & field of specialization, enlisted with C&W Department.

1. After commencement of work by the successful bidder, the additional security shall be released to the bidders in four installments i.e.25% to be released after completing 25% of the project and so on. In case the bidder quotes lower than 10% below the Engineer's Estimate and the bid is not accompanied by an additional bid security then bid shall be considered as non-responsive and will be disqualified.
2. All the bidding will be through E-bidding system. Technical bid should be in sealed envelopes clearly marked "Technical Bid" Technical bids shall be submitted through courier before closing time.
3. The bidders are required to quote their rates above or below on BOQ/MRS system on both MRS as well as non MRS items.
4. Technical evaluation will be carried out on the basis of (General experience, Personal Capability, Equipment Capabilities & Financial Soundness etc.) proper marking criteria as approved by Competent Authority. Failing to fulfill passing criteria shall be considered as fail leading to disqualification of the bidder.
5. Financial bid shall be filled online. Complete bids must reach the concerned offices on or before the fixed date/ time. The CDR or additional security (if required) shall be enclosed in the Technical proposal.
6. Any Electronic Bidder who provides incorrect information shall stand disqualified & de-barred.
7. Time allowed for the completion of the work as specified in the NIT shall start from the issuance of LOA.
8. Electronic Bids validity period is 90 days.
9. Successful Bidder should sign the agreement with the department within Twenty Eight (28) days after issuance of LOA.
10. Call Deposit of Scheduled Banks shall be acceptable.
11. If the evaluated electronic bid costs of two or more than two bidders are equal then the successful bid will be declared through draw.
12. Technical Bids will be opened after 30 minutes of closing time in the presence of bidders/ their representatives who choose to be present.
13. Financial electronic bids will be opened After approval of Technical Bid from Competent Authority.
14. The employer has the authority to reject any bid or all the bids assigning cogent reasons.
15. Bid security of the 1st, 2nd and 3rd lowest Electronic Bidder for the specific work will be retained by the Department till the approval of bids.
16. All Bidders/Firms must be Register with the Khyber Pakhtunkhwa Revenue Authority.
