1. Kindly append the attached checklists to the Emergency Response Manual which itself is now an annex to the POM.
2. Attach these to KITE ESMF and disclose the revised ESMF on the websites of C&W and TCKP. The old ESMF should be deleted. The file name appearing on the websites should clearly say 'KITE E&S Management Framework, updated with COVID19 checklists'
3. The checklists are for immediate implementation and Fazal Rabbi should kindly conduct a brief session with DGHS, ERKF PDs (include Asad from SMEDA also) and KITE PDs (and other team members) running them through these checklists during next week. It can be done virtually also using zoom or MS Team. Bank team doesn't have to attend that.
4. Jalal sb is requested to expedite seeking of an E&S resource from EPA (KP) on deputation to get these checklists implemented for KITE.
5. The checklists should also be attached to the ERKF OM and ESMF. Zahid sb will share the customized versions with the ERKF PD.

KITE wants to equip a quarantine center in Peshawar so the checklist for that will follow separately and can be disclosed on the websites separately also so no need to wait for it.
