1. The scheme was approved by the DDWP/DSC in its meeting held on 06.06.2024. Minutes circulated by C&W Department vide letter No.SOR/3-4/G-MTG/C&W/2024 Dated: June 10, 2024.
2. The expenditure involved will be met out from the Sanctioned budget under the function cum-object classification NC 21019 (015) "04-Economic Affairs-045-Construction & Transport-0452-Road Transport-045202 Highways/Roads and bridges during Financial Year (2023-24).
3. The Administrative Approval does not constitute any sanction to design, rates provided in the rough cost estimate. The suitability of design & financial responsibility of the rates rests with the authority competent to accord technical sanction to the cost estimate.
4. The sanctioning authority shall allow appropriate rates after observing all codal formalities/ standing instructions regarding schedule of rates and financial regularity. The work shall be taken in hand after release of funds and proper technical sanction of the cost estimate.
5. This AA is valid for the CFY & no liability shall be created and will not be throw forward to next financial year and expenditure shall be restricted to the actual release of funds by Finance Department.
