- 6. Proof of the asphalt plant ownership or work agreement on prescribed format.
- 7. Complete bidding documents duly signed.

- 3. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and/ or required amount of additional security, then the said bid will be dealt as per KPPRA Notification: S.R.O (14) /vol: 1-24/2021-22: dated May 10.2022.
- 4. In Case detailed rate analysis submitted with the bids is, in view of the procuring Entity not convincing, the Head of the procuring Entity may declare such bid as non-responsive.
- 5. Complete detail of Bid Security in shape of CDR i.e Bank Name CDR Number(s) and Date (s) must be submitted electronically along with E- bid on the E-bidding system.
- 6. In Cases of tie among the successful bidders, winner will be decided based on toss in the presence of all the bidders.
- 7. Bid not fulfilling any of the criteria as stated above and in the bidding documents will be declared non-responsive.
- 8. Submission of forged or misleading documents (if found at any stage) will result in disqualification. Additionally, punitive actions—including legal and financial penalties—may be imposed.
