2. The contractors quoting their bids upto a limit of 10% below Engineer's Estimate shall submit Bid Security to the extent of 2% Engineer Estimate only.

The Contractors quoting their bids more than 10% below upto 20% below on Engineer's Estimate shall submit alongwith their bids 8% additional security of Engineer's estimated cost in addition to 2% bid security. 5. In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid

6. The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such to bids or may advertise procurement opportunity afresh.
